MAG-FILER is an on-premise application and is suitable for businesses and accounting firms of just about any size. MAG-FILER can be installed on a desktop, laptop, or network, but does not offer online or mobile access.

MAG-FILER easily processes year-end compliance forms such as W-2's and 1099's, with both paper and electronic filing capability included in the product. MAG-FILER is a stand-alone application and does not require any additional modules in order to be operational. Users can enter 1099 and W-2 data manually or chose to import data from other applications including Microsoft Excel. New this year, MAG-FILER has

as W-2 and W-2G for all 50 states and the District of Columbia. The product supports e-filing to both the IRS and SSA and can e-file 1099's under the IRS Combined Federal/State program. The product will also file corrected 1099's, and MAG-FILER can be used to electronically file with states not in the IRS Combined Federal State program that require 1099 State Filing of 1099's, which includes California, Kentucky, Maine, Mississippi, Oregon, Pennsylvania, and Wisconsin.

MAG-FILER also includes a PDF printer, with users able to print all forms directly to a PDF if desired. Users can also import data from a variety of resources, including Microsoft Excel, QuickBooks, and text files. The product also transfers data from the previous year's product, eliminating the need to re-enter data.

Users can also run a Totals Report for each payer or each form type to ensure that the balance is correct. Users can print out totals of all original forms or corrected forms.
