ProConnect Tax Online offers intuitive system navigation, with a clean and uncluttered user interface. Users can access system features using the menu to the left of the screen, and there is an e-file dashboard available where all e-filed returns can be managed. offering a variety of features designed to make return navigation easy such as a super search option that allows users to search in a specific return terms such as name, amount, or even line number. The system also offers a split screen view, so users can view the form being prepared as well as data entry fields.
