Cloudvara specializes in QuickBooks hosting and is an Authorized Standard QuickBooks Host. Legal, accounting, and tax software hosting is also available, with hosting services available world-wide.

Cloudvara currently guarantees a 99.5 % uptime, with company servers located in a major data center in the U.S. All data centers employ state of the art security measures including SOC reporting, ISO certifications, along with both HIPAA and PCI compliance. All data is backed up daily, and anti-virus protection is provided for all data stored on its servers. In addition, hardware firewalls are used to protect data. Along with desktop and laptop access, users can access hosted applications from iPhones, iPads, or Android smart phones and tablets.
