Geared toward accountants providing a broad array of services to clients, Payroll CS opens within the CS Professional Suite Accounting interface's Home Page, which provides access to a master client selection screen along with quick links to firm tasks, forms, e-filing information and other program modules. Client selection options provide limited search and filter capabilities. Within the Payroll CS area of the accounting suite, a split-screen window provides intuitive icons for specific tasks, such as manually entering payroll data, printing checks, running reports, maintaining employee and vendor data, and generating transmittal letters.

and several smart entry fields provide lists for selecting common information.

Payroll CS can handle virtually any number of voluntary and involuntary preand post-tax deductions and offers payment functions for remitting withheld funds. These can include 401(k)s, union dues, cafeteria plans, child support, garnishments, insurance and others. Additional user-oriented tools include a gross-up calculator and ticklers for reminding users of specific tasks or due dates.

Among its web-enabled features, firms using Payroll CS can take advantage of remote client data entry, which reduces the time spent on routine tasks. Print-based form preparation options include the above forms, plus W-2s, W-3s, 1099s, 943 and 945. Managerial reporting output includes nearly 50 customizable reports that include check register and payroll journal, withholding, departmental
