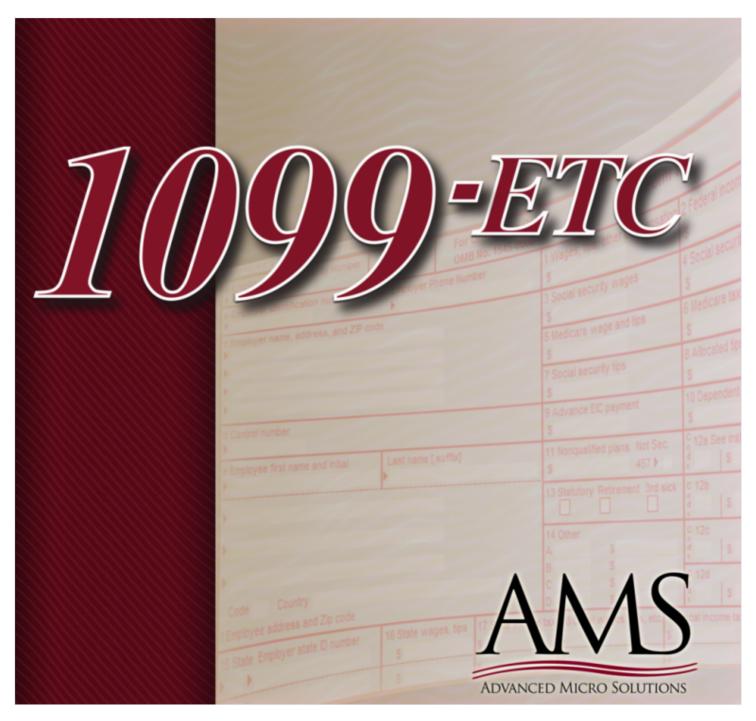

- A Common Payee File allows the user to select a Payee across payers/1099 forms without having to type in the same information multiple times.
- The Browse command allows the user to enter data using a spreadsheet format.
- Payer information only needs to be entered once.
- A description of the current field displays at the top of the form.
- Data can be imported from a variety of sources including; Excel, form print files and ordinary text files.
- The Default command allows the user to "define" default values for a form, such as State Code and ID.
- Selected fields can be calculated.
- Entry fields are selected using Tab, Enter, arrow keys, as well as clicking on field with the mouse.
- The data is automatically saved through our 1099 software when a new record or form is accessed, thus ensuring edited data is never lost.
