#### **SUMMARY & PRICING**

CYMA Not-For-Profit Fund Accounting is a terrific product, ideal for mid-sized organizations with multiple grant sources, although its modular structure would make it suitable for nonprofits of just about any size. CYMA pricing starts at \$645 per module, with typical installations beginning at about \$1,945 for three modules. Grant Tracking costs an additional \$395.
