

The internet domain for the service (e.g. firmname.com) is held by AccountantsWorld for the firm, and can be transferred to the firm's control at the conclusion of a Website Relief subscription for a \$50 per domain fee. The service is operated on virtual servers by a leading cloud computing company in a secure data center with third party security reviews. Backups are maintained in multiple data centers, with the databases mirrored to multiple locations for redundancy. The product includes five configurable POP e-mail boxes with 10GB per account of storage.

Integration with the AccountantsWorld CyberCabinet cloud-based document management and client portal service is available for those who subscribe to both services. The company reports that CyberCabinet can be operated in compliance with major regulatory requirements, including HIPAA, FERPA, and GLB. All of the AccountantsWorld PowerPractice suite applications are hosted in data centers within the United States.
