

The toolbar at the top of the screen offers quick access to Files, Tools, Reports, and Help options, and users can easily access recently used plans, review any notices, and access help functions from this screen as well. The main user interface screen is completely customizable, so users can create an interface that suits them. Users can click on the New Plan icon to quickly create a new tax plan, choosing options such as number of alternative plans and number of tax years to plan. Users can choose any number of years to compare, with the ability to compare an unlimited number of years if necessary.

Core Tax Planning Features: 5 Stars

Once criteria have been established for a new plan, users can easily create a variety of tax options. Navigational tabs are included for quick access to various tax options such as Income, Activities, Adjustments, Deductions, and Other Taxes, as well as ACA, AMT, Credits and Payments. The Main screen offers an overview of the tax planning results and additional tabs take users to other options such as Tax Projection, Exemptions, and Analysis, along with others. Taxes are calculated automatically as data is entered, though users have the option to turn the automatic calculation option off, if desired. Users can easily create tax scenarios from scratch, or import data from CS Professional Suite applications.

The product also allows users to set target amounts for their clients, with Planner CS calculating the amounts needed in other areas to reach the stated target.

Built-in word processing functionality allows users to create custom letters, inserting planner data into the letter if desired. The Print Report option allows the system to auto select reports to print, or users can choose to print a Tax Projection Report, or a Report Set, with users able to view all reports onscreen prior to printing.
