prepare for their future liabilities. To offer these services, however, it is essential to have the right tools. Many preparation systems, even those designed for tax and accounting professionals, aren't designed for planning.

Yes, traditional tax systems can be used to perform basic scenario testing for a specific tax year, but there are often financial issues that have taxation implications over several years. Tax planning systems also offer advanced ratio analysis functions, quick access to multiple scenario comparisons, anticipated phase-out limits, options for inflation-pegged factors, state planning capabilities and other functions.

Despite the old axiom about only two things being certain in life — death and taxes — there is a lot to be uncertain about as professionals prepare their clients for the 2010 tax season. As of the writing of this article, Congress has yet to act on the AMT patch, the extension of the Bush tax cuts, the estate tax and other issues. That only makes it more critical that professionals provide sound planning for each of the scenarios that face an individual client and that they plan with the potential for passage or non-passage of the above legislation.
