Today, the IRS announced that it added Tumblr to its list of social media platforms. Taxpayers and professionals who want tax information now have another way of accessing helpful tax tips, videos, podcasts and more at Tumblr.

Tumble is a microblogging platform where users access and share text, photos, videos and other information from their browser, smartphone, tablet or desktop.

The IRS plans to use Tumblr to help share information about important programs to help taxpayers, such as late tax law changes, the Earned Income Tax Credit and Free File. The Tumbler site also makes it easy for partner groups and others to share tax information from the IRS.
