

Q&A:

What advice would you give to female college students about the opportunities for women in the accounting profession?

Some of the best opportunities you'll have (and the best way to build your brand) evolve from engaging outside of the classroom. Look for opportunities to go 'above and beyond'; show your commitment and passion for accounting and it will pay off ten-fold.

What advice would you give accounting firms on things they could do to better retain and advance more qualified female staff?

I have engaged with many young female accountants recently as part of our efforts to connect with the next generation of accountants and it's becoming increasingly clear that this group often feels as though they don't have a fair chance to move up in the firm and that their career opportunities are limited. Involving young women (and men for that matter) in decisions about the future direction of the firm will go a long way in retaining great talent. They often feel as though decisions are passed down with no clear rationale as to why and that they have no opportunity to participate.

Do you think that there is still a glass ceiling in accounting firm senior management and partner levels, or that the profession has moved to a mostly gender neutral state?
