Within the system are a number of modules that enhance the offering and provide accounting professionals a complete payroll processing solution. New this year is the ability to import time information directly into the system and a new reminder feature.

1099-Etc. is a modular payroll system centered on a core W-2 and 1099 processing module. Additional modules may be added to present users with a complete system to process live or after-the-fact payroll. The system is designed to install on a user desktop, but server installations are available and are included with the licensing fee. Multiple users may be setup in the system and each user receives a specific login

combination. Additionally, access to specific payroll client data may be locked

Social Security Numbers and Taxpayer Identification Numbers may be verified in bulk through integration with the respective verification services to help ensure the most accurate payroll processing. Multiple state processing capabilities are provided through an available module. Payroll checks may be printed with MICR encoding or direct deposited through the use of an ACH file which can be submitted directly to the financial institution or an affiliation with National Payment Corporation.

Reporting & Monitoring: 4.25 Stars

1099-Etc. includes all tax tables for federal and state payroll processing. Forms are available for all states as well as Washington D.C. and Puerto Rico. Some forms will require users to enter some data that is not collected as part of the payroll processing. Electronic filing is supported for federal and most state quarterly returns. Direct deposit information for employee and contract workers is available through the use of an ACH file which can be submitted directly to the financial institution or an affiliation with National Payment Corporation.

New for the current release, is the use of reminders for each payroll client. As users access the payroll client files, reminders prompt users for upcoming tasks and due dates that are set up by the user.

For users that prefer to skip processing payroll or need to quickly fill out a form, an available module with access to over 300 user fillable forms can be used. Each form may be printed on pre-printed forms or on plain paper. Batch printing features are provided so users can process multiple payroll client print jobs simultaneously. In addition to forms, a variety of reports are provided with the system but currently no custom reports may be created. In addition to paper form, all forms and reports may be natively saved PDF files.
