

From 2011-2012, Anton served as chair of the AICPA's Board of Directors, which now represents approximately 412,000 members worldwide. He served on the board from 2006-2009 and 2010-2013, and presently serves as part of the AICPA delegation to the International Federation of Accountants. He is the founder of the Institute's "What's at Stake" initiative, which promotes federal fiscal responsibility.

Anton served as chair of the Colorado Society of CPAs (COCPA) during its centennial year. He co-chaired the COCPA's Foundation's Centennial Scholarship Campaign, which raised over one million dollars for college accounting scholarships. He is past president of the University of Northern Colorado's Alumni Association and also served as past chair of the school's Accountancy Advisory Board.
