

In what ways have you contributed to your firm/company to make it better?

I participate regularly in charities that promote free enterprise and the importance of accounting. Some of those groups include Enactus (formerly SIFE), Junior Achievement, and several financial literacy projects.

What changes do you foresee in the accounting profession of the near future (3-5 years)?

Compliance services will soon be done through Artificial Intelligence systems. This includes tax return preparation, payroll services, and the day to day bookkeeping work. Software already is pushing us toward more advisory roles. Clients will begin to ask more time of accountants as it relates to strategy. We are also starting to see package pricing and published pricing on websites start to flourish. This will continue as clients demand more transparent services.

How do you see yourself participating in shaping the future of the accounting profession?

Software development has become a major focus of mine now. I learned how to code several years ago, and I have built a team of developers that work on several projects at once. Our newest and most promising initiative is a software called "Halon Tax". This is a tax software that blends artificial intelligence with real tax professionals to offer business tax return preparation. My hope is to focus on the areas of tax that can be automated and bring software solutions to market that provide those services at a fraction of what they used to cost.

What is your career philosophy?

Work hard and take pride in the work you do. Take good care of the staff that supports you. Constantly be finding ways to improve your business and your expertise in your field, never stop learning and seeking ways to do and be better. I'm
