In my 13 years of being a member of the firm, I've served on a number of internal committees, task force groups, etc. A few examples include participating in a group to develop incentive compensation plans and leading a growth task force as part of a recent strategic planning meeting. Most recently, I have served as the chair of the THF recruiting committee where I am responsible for coordinating recruiting efforts with Florida State University, Valdosta State University, and University of South Florida. Being head of the recruiting committee has allowed me to help recruit talented individuals that will be the future of our firm. Additionally, I authored a formal training program for the tax department that provides timelines and training materials/procedures on a week-by-week basis which is provided to all new hires. This program has allowed us to successfully integrate new employees into the tax department. I also lead our firm's commercial-focused industry team comprised of fourteen professionals whose primary focus is on successfully serving private companies. Within this team, I spend a lot of time mentoring the younger CPAs and helping them become more engaged in the local business community.

improving outsourcing of traditional non-core accounting functions such as accounts receivable, accounts payable, bank reconciliations, etc. I believe more and more companies will follow suit and begin to outsource these services which will create a new revenue source for CPA firms. Advances in technology are allowing CPA firms to offer these services in an efficient and cost effective manner. Companies are beginning to realize that some of these services can be contracted out at a lower cost than maintaining a full-time employee along with incurring the related costs of payroll taxes, benefits, etc.

6. **How do you see yourself participating in shaping the future of the accounting profession?** My hope is that I will influence future accountants that we hire and others that I get the chance to meet at campus recruiting events. I hope that they will take away that being a CPA is an exciting career and a privilege. The profession needs talented candidates coming into its ranks.
