

W-2/1099 Forms Filer can be used as a stand-alone product. All year-end forms are generated using this product, with users able to utilize additional products from the vendor in order to support and bolster functionality of the product. Forms supported in the product include W-2, W-2C, W-3, all 1099 forms, 1096, 1098 and 5498. The product easily handles up to 1,999 separate payers/employers, and up to 99,999 employees per payer. W-2/1099 Forms Filer uses an interface screen that mimics the actual form, so data entry is quick and painless. Select fields in the forms offer calculation capability, and users can set up default values for commonly used fields such as state codes, and ID numbers. The product also creates a SSN verification file, so users can quickly verify Social Security number with the SSA. The system also creates a TIN validation file that can be submitted to the IRS.

All W-2 and 1099's processed using the product are designed to print on pre-printed forms, but the optional Software Generated Forms module allows users to print year-end forms on blank paper if desired, except for Copy A of 1099 forms. Forms Filer Plus offers users access to additional federal and state tax forms, with data entry handled in a similar fashion; with users entering data directly into a form that is displayed on screen. Once the form has been completed, it can be printed as needed.

The Table Report generates hash totals of social security and tax ID numbers for quick review, and the product also handles all worksheet related reports. Users can
