- Since 2007, there have been 2,172 new sales and use taxes, an average 217 per year.
- Since 2007, there have been 3,985 sales and use tax changes, an average of 399 per year.
- The combined number of new and changed sales and use tax rates since 2007 is 6,157, an average of 616 per year.
