UltraTax CS is part of the CS Professional Suite of applications from Thomson Reuters. Best suited for large accounting firms, UltraTax CS can be used as a stand-alone application, but performs best when coupled with other CS Professional Suite applications. Designed for efficiency, UltraTax CS can be deployed in a variety of ways, including on a desktop or network, accessed as a hosted solution or as a SaaS application.

UltraTax CS does not offer mobile accessibility, though there are mobile apps for both Practice CS and NetClient CS, with both products integrating with UltraTax CS.

The UltraTax CS homepage is designed for efficient navigation, with users able to access a variety of options, including e-filing news and transmission status, direct

access to product guides, staff monitoring tools, client profiles, and software updates.

UltraTax CS supports 1040 e-filing including federal returns and 1040 returns for all states that accept e-filing. The product also offers business e-filing for federal forms 1120, 1120S, 1041, 990, 5500, as well as numerous state returns. The product also supports FinCEN Form 114 e-filing for foreign bank reporting for 1040, 1120, 1065, and 1041. To simplify the process, UltraTax CS offers a variety of tools to make e-filing more efficient, such as the ability to error-check a return while it's being processed. The product calculates data as its entered, and offers AMT calculations, passive activity capability, and an optional oil and gas module that calculates depletion, tax references for percentage depletion, and tracks depletion on a well-by-well basis. UltraTax CS also alerts system users to potential problems or missing data.

The Web Client Organizer allows users to create a custom questionnaire for each client, which they can access and answer via the firm website. Completed questionnaires can then be imported directly into UltraTax CS, with no additional data entry needed. The NetClient CS Portal allows clients to share source documents securely and completed tax returns can be posted to the portal as a read-only PDF for easy client access.

Workpapers CS provides firms with the ability to easily manage work papers and source documents. For a more paperless approach, users can integrate FileCabinet CS with UltraTax CS, which will organize, store, and archive any document, making it easy to distribute files to colleagues and clients alike. Files are easily accessible directly from UltraTax CS, so users don't even need to open FileCabinet CS.

UltraTax CS offers seamless integration with other CS Professional Suite applications including Accounting CS, Accounting CS Payroll, Checkpoint, FileCabinet CS, Fixed Assets CS, GoFileRoom, NetClient CS, Onvio Firm Management, Planner CS, Practice CS, and Workpapers CS, enabling firms to utilize a central system that offers tax

planning and preparation, practice management, document management, and a

UltraTax CS is a robust tax compliance application that is best suited for larger accounting firms that prepare complex tax returns for a variety of clients. Though UltraTax CS can be used as a stand-alone application, it truly shines when coupled with CS Professional Suite applications. Pricing for UltraTax is customized for each user and is typically based on the number of users and deployment option chosen, with the product usually starting at around \$3,000 for a single user, with product support included in the pricing.
