TIC provides feedback and comment letters to standard setters that impact private entities and their CPAs. The standard setters *do* read your letters and take them into account when drafting final guidance. I encourage you to write a letter when a standard impacts you (or your client, if applicable). You don't have to be overly technical in your response or even answer all the questions; your voice is important.
