A more diverse and inclusive profession will be better equipped to address the shifts in entrepreneurial capital that will result from these changing demographics in the U.S.

This program was created in honor of George Willie, CPA, CGMA, a former chair of AICPA's PCPS Executive Committee and the AICPA Minority Initiatives Committee. Throughout his over 35-year career, Willie has promoted the benefits of a career in accounting to students and young professionals in pursuit of the CPA designation.

The program is open to Black or African American; Hispanic or Latino; Native American or Alaska Native; Native Hawaiian or Pacific Islander; Multiethnic; or Asian American students. Qualified applicants must be pursuing an undergraduate or graduate degree in accounting or an accounting-related major with a GPA at least 3.0 (on a 4.0 scale) overall and for their major. They also must plan to sit for the CPA exam. Full eligibility requirements are available online.

A scholarship selection task force will review all qualified applications and select up to five scholarship recipients based on academic achievement, leadership and future career interests in accounting.
