are frequently missed by others in the profession? Just be careful what you say because everyone is watching. I'll give a real-life example: Just a couple of weeks ago, we were looking to hire someone for a reception job. She did fairly well in the interview. She went home that night and posted on her Facebook that the interview was "ridiculous" because she didn't like one of the questions I had asked. As it happens, one of our interns knows her and is friends with her on Facebook and he forwarded her post. Needless to say, she didn't get the job.

Do you embrace cloud computing? There are differing definitions of what *cloud computing* really is, but we have been using the full suite of Thomson products on Virtual Office for several years. So all of our applications are accessed and run over the Internet and not a local server.

How is cloud computing changing the accounting profession, and how concerned are you with the security issues related to cloud computing? If you choose a solid provider, I believe your security exposure is minimal. All of our applications are hosted at the Thomson Data Center in Egan, Minnesota. Thomson is a multi-billion dollar company that isn't going anywhere and must maintain the highest level of security just by the nature of the company. In my opinion, if you have client files laying around your office or even on a local server that isn't kept up to date, then you have more exposure than if you have your applications and data hosted with a solid cloud computing vendor.

Do you foresee the majority of firms still implementing servers for the majority of their computing in their offices five years from now or do you think they will be outsourcing this component to vendors who specialize in this area? A majority of the firms out there are small firms (close to 30,000). I foresee many of these small firms either moving to cloud computing or being acquired by someone who is already in the cloud. For some of the large firms, it may not make sense in terms of

the cost to use a third party for their cloud. But I certainly believe they will all be in
