FUND E-Z offers both on-premise and cloud-hosted deployment and is currently offered in two versions: Basic and Pro, with smaller nonprofits able to easily scale up to the Pro version if necessary.

The Basic version of FUND E-Z includes a standard chart of accounts that can utilize up to 22 characters, with accounts supporting up to six characters in length, while

FUND E-Z includes a Fundraising program that allows users to easily manage donors, gifts, and pledges, as well as manage campaigns and appeals. A mail merge function is also included that can be used for direct mail campaigns. Multiple grant funds can be tracked and separate budgets created for each grant.
