Users can publish client files directly to the portal, and the portal is bi-directional, so clients can easily upload source documents and other files to the portal as requested.

The product also includes a Microsoft Outlook plug-in that allows users to securely store client emails directly in their folder. For those that wish to scan documents, the product offers easy integration with CCH ProSystem fx Scan, with CCH ProSystem fx Document able to read, identify and bookmark any client document scanned.

CCH ProSystem fx Document offers an excellent selection of document management features including the ability to copy or move any file, the ability to lock a file, and the ability to rename a file.
