Intuit Online Payroll for Accountants is designed specifically for accounting firms that are interested in offering payroll and related services to their clients. Intuit Online Payroll for Accountants can be used as a stand-alone payroll application, but will offer greater functionality when used in conjunction with other Intuit or QuickBooks applications.

Intuit Online Payroll is designed to make the payroll process smoother; notifying firms when a client pay date is getting close. Users can choose any or all clients from the user dashboard, and once a client has been chosen, a list of all employees and contractors that need to be paid will display on screen, with their pay type included. The application supports a variety of pay types, including regular pay, commissions, allowances, reimbursements, overtime, PTO, and sick time. Mentioned earlier, this process can be completed by the client, or by the firm, depending on the access levels provided to the client. Direct deposit is supported by Intuit Online Payroll, and is included at all pricing levels at no additional cost.

Intuit Online Payroll includes tax tables for all 50 states, and users will receive an email notification when taxes are due. Quarterly tax filings for Form 940, 941, and 943 are available, and both W-2 and 1099 processing is supported as well, with all forms filed electronically as permitted.

Intuit Online Payroll includes a good variety of payroll related reports, including both summary and detail reports. A Tax and Wage Summary report and a Tax Liability report are also available. All Intuit Online Payroll reports offer basic customization capability, with users able to export reports to Microsoft Excel if further customization is desired. Another handy feature is the ability to create custom groups reports for each client if necessary.

Time data can be imported into Intuit Online Payroll using an Excel spreadsheet, or users can opt to use TSheets, which offers automatic time tracking, real time reporting, and direct integration with Intuit Online Payroll. The application also integrates with popular QuickBooks applications including QuickBooks Desktop, QuickBooks Online, and QuickBooks for Mac.

Intuit Online Payroll offers users an employee portal which they in turn can offer
