Source Document Processing, available as an add-on module for Thomson Reuters CS Professional Suite, offers integration with FileCabinet CS, Workpapers CS, and UltraTax CS. Not available as a stand-alone application, Source Document Processing's purpose is to streamline the tax preparation process by reducing or eliminating the amount of data entry necessary when preparing a tax return. Source Document Processing is a hosted application, available via Virtual Office CS or as a SaaS application.

Core Product Functions/Features: 4.5 Stars

Designed to work with other CS Professional Suite applications, Source Document Processing first teams up with FileCabinet CS to identify and extract data from a variety of source document types, using optical character recognition (OCR) to accurately identify and extract data from the documents. Users can opt to scan documents into Workpapers CS, where they can also create a specific page sequence that helps to ensure that all documents are sorted in a consistent manner.

Once the scan is completed, users can then transfer the completed scan to the Source Document Processing add-on module. Once they've been transferred, the documents are ready to be transmitted to Thomson Reuters data center, where they are organized and labeled by employer or payer. Once this organization has taken place, the documents are available to access in both FileCabinet CS and Workpapers CS.

In addition, Source Document Processing allows users access to the source data entry
