There are two available versions:" 1) The W2/1099 system, which includes only federal forms required for compliance; and 2) Payroll Compliance Reporting, which adds forms for State and local payroll reporting.

Both versions of Payroll Compliance Reporting process W-2s and 1099s, with the form entry screen mirroring the form being processed. Information worksheets are available for W-2s, 1099s, or 1098s for both payers and employers. In addition to filing with the appropriate agencies, these solutions also prepare W-2s and 1099s that can be distributed to clients and their employees and recipients.

Payroll Compliance Reporting and the W2/1099 system offer solid help functionality, with built-in application and form help. Users have access to a variety of training webinars, self-help videos, knowledgebase articles, and a new user orientation. Users can log into the Solution Center to download the product access the learning portal, and obtain other helpful account information. U.S. based phone support and chat are offered during regular business hours, with extended support hours available during tax season.

In 2020, both Payroll Compliance Reporting and W2/1099 include the new form 1099-NEC which will be used to report non-employee compensation. (Because the IRS is not supporting the 1099-NEC as part of the Federal/Combined program, preparers will need to file the 1099NEC directly to states as required.) Both products support multiple users, as well as unlimited payers and unlimited recipients, which is a necessity for accounting firms that typically process year-end compliance forms for numerous clients.

The 2020 version of the W2/1099 solution is priced at \$285, with the full Payroll Compliance Reporting solution costing at \$489. Both products can process and e-file forms W-2 and W-3 with the Social Security Administration, and forms 1099, 1098, and 5498 with the IRS. W2/1099 will also file quarterly returns such as Form 941 and annual Forms 940 and 944 with the IRS using the IRS Modernized e-File System. Both products can also process an unlimited number of payroll returns at \$\$1.60 per TIN for the first 100 TINs.
