His official volunteerism service for AICPA began in 1989, spanning more than 30 years.

"As an advocate for CPAs and their role providing planning services, Charles has paved the way for the future generations of CPA financial planners."

Kowal led the charge when financial planning regulation was threatened in the 1980s and testified on behalf of AICPA before a Congressional hearing on proposed financial planner/investment adviser legislation in the 80s. He has been involved more recently with advocating for clarity to SEC IA-1092, commenting on SEC's Reg BI and advertising rules, and positioning on financial planning regulation. He has made significant contributions to many initiatives including task forces charged with editing the Fiduciary handbooks, creating and updating the Statements on Responsibilities in Personal Financial Planning Practice first promulgated in the 1990's, and leadership around acquiring standard setting authority for the PFP Division in 2012 which led to issuance of the AICPA's Statement on Standards in Personal Financial Planning Services.
