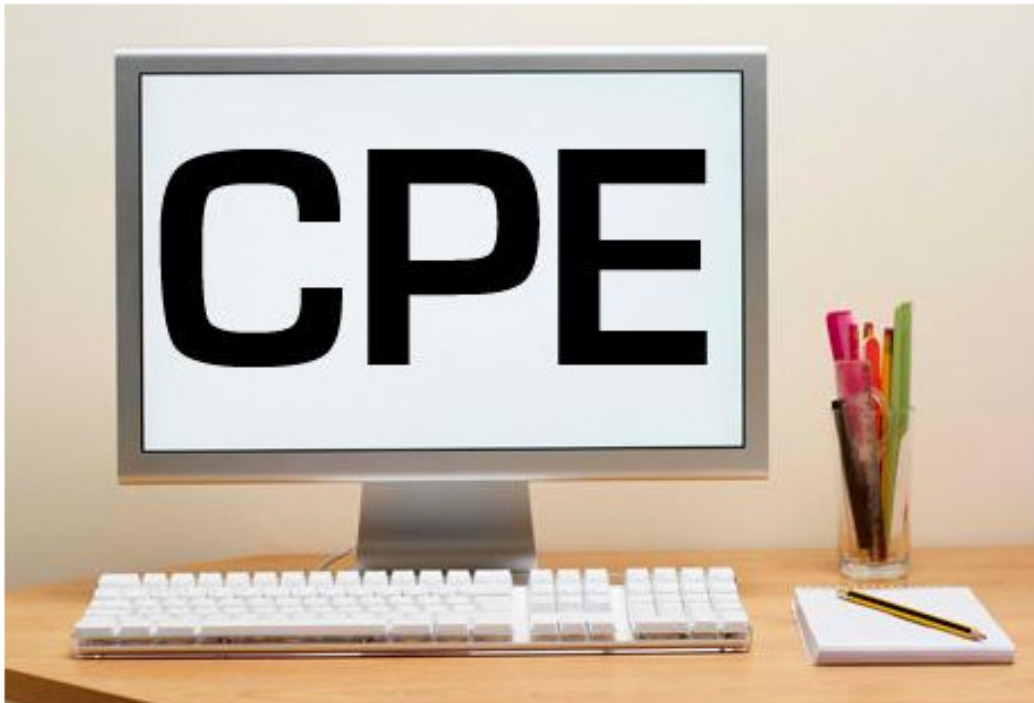

Continuing professional education (CPE) refers to ongoing training that is required in certain professional fields in order to remain certified. As a CPA, continuing professional education should be a lifelong pursuit that will allow you to retain your current knowledge and competency while also staying current with changes in the profession and obtaining new skills.

Although requirements vary by state, all licensed CPAs are required by their state boards to obtain a specific number of CPE credits to remain licensed.

CPE credits are measured with 50 minutes equaling 1 CPE credit. Luckily, since a

CPE standards are published and maintained by two organizations; the National Association of State Boards of Accountancy (NASBA) and the American Institute of Certified Professional Accountants (AICPA).

The actual number of CPE credit hours that a CPA will need annually varies from state to state, so be sure to refer to the state where you're licensed when determining the number of courses you'll need to take as well as the required length of time for accumulating the CPE requirements for your state. For example, some states require 40 CPE credits per year, while other states require 120 hours over a three-year period, which allows you to take more courses in a single year, or skip a year entirely and then obtain the required CPE credits over the next two years.
