RULES FOR NOMINATION

Anyone can nominate a product or service for an award (vendor, user, third-party). There is a nomination processing fee of \$295, which covers the costs of evaluation and logistics. Each product or service can only be nominated once. If you nominate a product or service that has already been nominated, your nomination fee will be returned. The selection process is determined by the subjective opinions of the members of CPA Practice Advisor's Awards Committee and does not use outside votes or user testimonials during the process.

Award nominations will be initially screened for compliance with the following conditions of eligibility for the awards.

Nominated products/services must:

- 1. Be commercially available (no Beta versions)**
- 2. Be less than two years old** (Note: Significant new modules or features, or programs that have undergone a major revision or version change are eligible, regardless of longevity of overall product.)
- 3. Be directly marketed to the tax and accounting profession**
- 4. A nomination fee of \$295 must be submitted on the second page of this nomination form for a product to be eligible.**

Those not meeting these conditions will be removed from the nominee pool at no charge. The awards will be announced in the August issue of CPA Practice Advisor magazine.
