Dayron Garcia, the first of two recipients of the ALPFA scholarship this year, is a sophomore at Monroe College majoring in accounting and taxation. Garcia, who identifies as disabled, hopes to shine a light on misconceptions surrounding disabled individuals in the workplace.

"My hope is that I can show people that those with disabilities are just as capable of success in the business world as anyone else," said Garcia. "We deserve the same
