The current CEO of Deloitte & Touche is Lara Abrash, who took over in June 2019.

He added, "I believe deeply in Deloitte's responsibility to lead through the unprecedented pace of change the world is experiencing, and to meet the rapidly expanding needs of our stakeholders. I want to thank Punit for his excellent leadership of Deloitte."
