For its ranking, Vault asked more than 11,000 accounting professionals to complete a survey that consisted of questions about life at the accountant's firm (or former firm) and a prestige rating. Survey participants were asked to rate firms other than their own on a scale of 1 to 10, with 10 being the most prestigious. Participants were asked only to rate firms with which they were familiar and were not permitted to rate their own (or former) firm.
