Each year, these awards, which are named in honor of McKeever—a passionate civic leader and advocate for increasing diversity in the accounting profession; partner at Mitchell & Titus LLP; managing principal of Washington, Pittman & McKeever LLC; and a founding member of the CPA Endowment Fund of Illinois—are presented to an Outstanding Leader and an Emerging Leader in recognition of their commitments to advancing diversity, equity, and inclusion (DEI) in the accounting profession.

“Advancing DEI initiatives is critical to ensuring we attract and retain talent that reflects the diversity of the country as well as the clients and communities we serve,” says Geoffrey Brown, CAE, ICPAS president and CEO. “The recipients of these awards inspire positive change and deserve our recognition for their efforts to make the CPA profession both welcoming and rewarding to all.”

The following honorees will be recognized at the ICPAS Leadership Recognition and Awards Dinner on June 8, 2023, in Chicago.

### *Outstanding Leader*

- **Kimi L. Ellen, CPA**, is a co-founding partner of Benford Brown & Associates LLC in Chicago, which is one of the largest African American women-owned accounting firms in the country. Ellen has worked tirelessly throughout her nearly 30-year career to create opportunities for Black and other racially and ethnically underrepresented individuals in accounting to find success and advance in the profession. Ellen is an active member in the American Institute of Certified Public Accountants; Diverse Organization of Firms, a membership organization for minority-owned CPA firms in the U.S., where she serves as chairperson; ICPAS, where she serves as a director on the board; and National Society of Black Certified Public Accountants, where she serves as the chartering parliamentarian. Further, Ellen serves as president of the Southeast Chicago Chamber of Commerce. She’s also the board treasurer at Access Community Health Network, which is the largest federally qualified health care center in Chicago. Ellen also volunteers as chairperson of the Associates Group of the Windy City Chapter of Jack and Jill of America Inc., treasurer of the Chi Omega Omega Chapter of Alpha Kappa Alpha Sorority Inc., and parliamentarian of the Lake Shore Chapter of the Links Inc. Ellen earned her bachelor’s degree from the University of Illinois at Urbana-Champaign, where she also served as president of the Minority Commerce Association.

### *Emerging Leader*

- **LaToya C. McKinney, CPA, MSAA**, is a senior business process and control analyst in Abbott's Rapid Diagnostics Division. McKinney is a passionate advocate for diverse students interested in accounting and is committed to leveraging her experiences and connections to support others. She serves on Abbott's finance diversity and inclusion team, which focuses primarily on recruiting minority students for internships and finance professional development program opportunities. Additionally, McKinney serves on the Communications Committee of Abbott's Black Business Network Chicagoland Chapter. Further, McKinney is a vice president with the National Association of Black Accountants Inc. in Chicago, is a member of Sigma Gamma Rho Sorority Inc., and is an active member of ICPAS, where she often volunteers for various DEI initiatives, like the Mary T. Washington Wylie Internship Preparation Program and the Scholarship Selection Committee. McKinney earned her bachelor's degree from the University of Illinois Chicago and her master's degree from Chicago's DePaul University.
