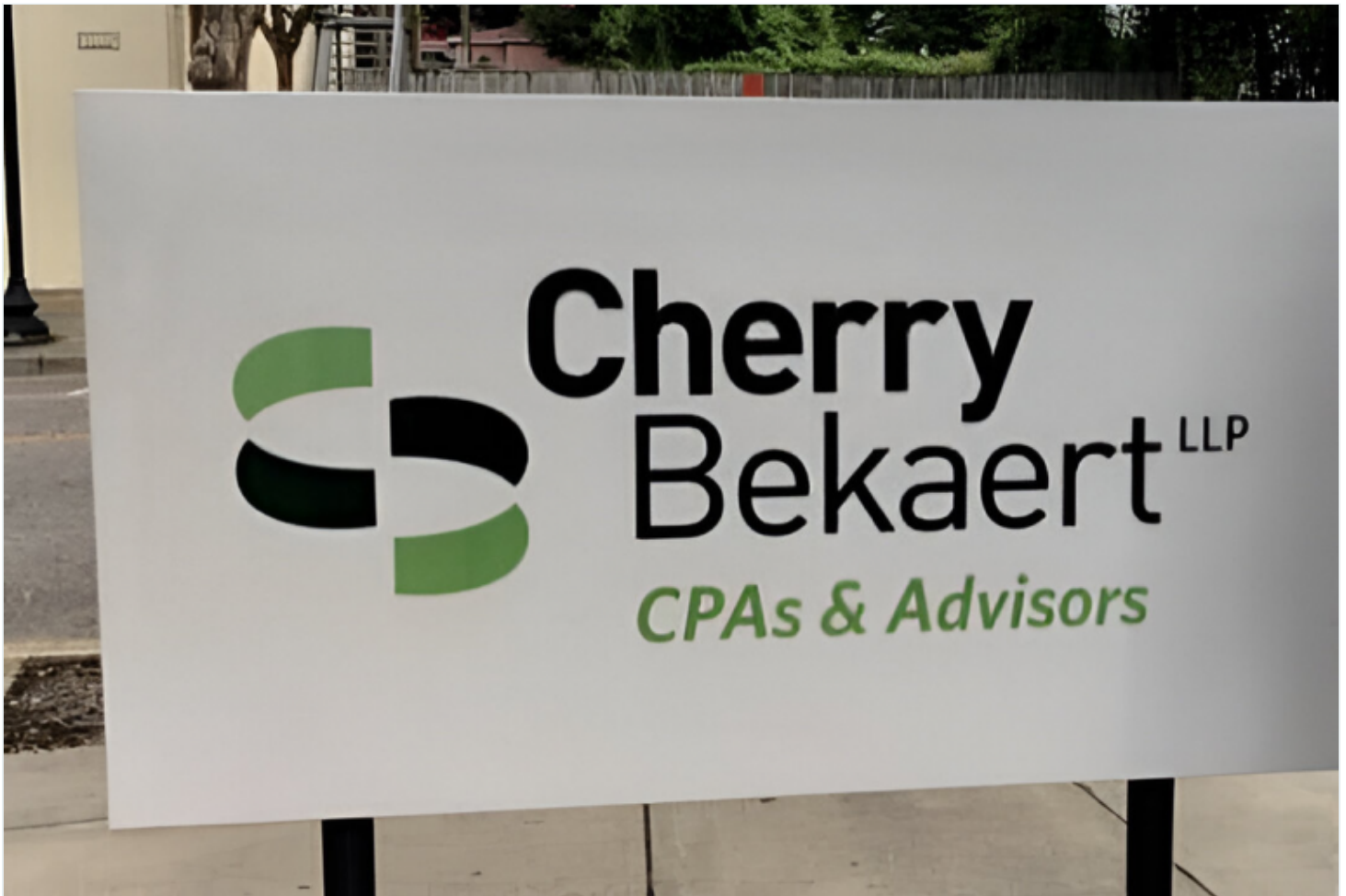

Combined they have more than 250 employees and approximately \$48 million in total annual revenue.
