Their program kicked off with a Welcome Reception for the Scholars in September, their guardians and each of their selected mentors, followed by a Campus Visit to Purdue University in October, and then next week's College Night to learn about the college application process and financial assistance options.

"We're always thrilled to welcome and meet our new class of Scholars," said INCPAS President & CEO Courtney Kincaid, CAE. "Each of these students are taking a very grounded, thorough approach to planning their professional future.
