

### Connect with the cloud

#### Accounting software has long been a crucial tool for accountants and bookkeepers across the globe.

For years you have used accounting software to record and process transactions, with the aim of increasing productivity and serving your clients to the highest possible standards.

Accountants are seen by their clients as a **trusted business advisor**, so having access to clients' most up-to-date financial information at the click of a button in order to provide them with actionable, proactive business advice is of paramount importance.



#### Low set-up costs

#### We spoke to two accountants to find out how the cloud has made their services unbeatable.



#### Meet Alan Peace,

a Chartered Accountant and owner of Swift-link Business Services.

Once a traditional accounting firm with an office and two other members of staff, Alan began using cloud technology to service his clients and now operates completely online and works remotely. "I was renting an office with two members of staff," he recalls. "We had peaks and troughs of workload – I did the calculations and realized that I would be no worse off working from home and going online. It was scary but I made that bold jump."

Peace moved out of the office, found his staff new employment, set up business at home and told his clients of his online plan. "I'd been looking for years to get data from my clients without waiting for receipts," he explained. "I wanted to get rid of that and find a cloud system where the data could be stored and even out the workload through the year."

After browsing the market, Alan settled on two cloud solutions; one which perfectly suited clients who "don't know what credit or debit is", and another platform for his larger clients.



"Most of my clients were a bit apprehensive [about cloud] because they didn't want extra work to do and they were worried about their data being hacked. I assured them that everything was encrypted and the integrated nature [of the cloud] meant it was easy for them to manage," said Peace.

Alan's small business clients, many of whom are tradesmen, have been able to get on with what they do best – running their business. "They want to fit their boilers and go home at night without having to worry about their accounts. The cloud is brilliant for cash-based workers – payments in, payments out. Simple."

And Peace has been able to grow his business, which now serves around 40 clients, many of whom are small business owners.

"For one person working from home that's quite a lot! But using a cloud system makes it manageable," he explains.

Peace has no regrets about the move to the cloud. "You are in control of your time," he says, adding that freedom of how and when he chooses to work has been both liberating and productive.

"Although I never need to meet my clients in person, I make a point of seeing them every now and again. You have to maintain that face-to-face relationship between accountant and client."

Moving to the cloud, he says, "is a great way to work".

#### Meet Elaine Clark.

Managing Director of awardwinning online accountancy firm CheapAccounting.

We spoke to Elaine to get her thoughts on why the cloud is so important, and why some accounting professionals have yet to embrace the technology.

"I'm a great believer in flexible working and mobile workforces." Elaine has been using the cloud for her firm since it started in 2007, having first designed a cloud system of her own to meet her and her clients' needs.

**Sage:** What sort of an impact do you think cloud technology has had on the accountancy profession?

**Elaine:** "I think it's totally transformed the profession.

"It gives clients much more information about the work that the accountant does for them and it allows clients to split tasks between services they have their accountant perform and the services that they can perform themselves, helping the client to bring their costs down." **Sage:** You've been using the cloud for nearly a decade. What was the deciding factor in moving to the technology?

**Elaine:** "I'm a great believer in flexible working and mobile workforces and in this day and age people can work from anywhere.

"With the cloud your clients can reach out to you about the financial health of their business and you can connect with them when it suits you both.

"Working in the cloud doesn't limit accountants to meeting up with clients just once or twice a year – you're having a lot more interaction with clients throughout the year, so you know that they are always going to be connecting with you, which is great for client retention."





**Sage:** Why do you think some accounting professionals haven't started using cloud?

**Elaine:** "The world is changing but some accountants are slightly slow in catching up with the developments in technology. Some just don't like change – it's as simple as that."

**Sage:** What advice do you have for accounting professionals who are unsure about moving to the cloud?

**Elaine:** "The advice that I always give to accounting professionals is to analyze your client list.

"At first they may look at their client list and think: 'I can't move to cloud, it's too big of an operation', but my advice is to break your list down and consider which clients are going to be more open to moving to the cloud. "That way you can break down your 'to do' list into manageable chunks, making the task seem less daunting.

"However, to do this you've really got to know what you want to do within your own practice. Yes, you've got to look at your clients but you've also got to internally look at your practice and how you will structure yourself to run a digital practice."



### Five ways to make a stress-free switch to the cloud

#### **Do your homework**

There are various cloud accounting software providers out there, but not all of them will be suitable for you and your client's needs.

#### **Pick the perfect clients**

As Elaine Clarke advised, one of the first things you should do when moving to the cloud is to consider which clients are going to be open to make the switch with you.

Make a list of all your clients, and divide them between those who will favor the move to cloud, and those who won't. By doing this you can ease your way into the cloud naturally, making it a collaborative process between you and your clients.



#### Open up a discussion with your clients

So you've chosen which clients will benefit from cloud-based accounting software, now engage with them directly.

Set up a face-to-face meeting or an online conference call with them to run them through the various cloud options to choose from. It may be the case that your clients have wanted to move to the cloud for a while now, so they might have already picked their preferred solution.





#### Get the training you need

You've picked your cloud accountancy software, now you need to know how to use it.

Many accounting software providers will have training packages available, and their customer support teams will be more than happy to answer any concerns you may have.
